I. Introductions

The meeting was called to order at 9:08am

II. Consent Agenda:

1. July 2022 Meeting Minutes There were no questions or comments.

III. Discussion Items

1. La Plata County Transportation Plan

This was on the agenda but didn't have any updated information. Clyde expressed interest in having a map that shows all routes and a call center for the region. A web-based call center has been of interest. Jay with Roadrunner is working with all the counties through Bustang to coordinate some service and looking at what would be a fair price to cross the region. Getting seniors that live rurally to the senior Center is a gap. There was discussion that it takes 45 minutes one way to get to Marvel.

2. Region 9 Update

Laura provided and update on the SWCCOG transition and the history of Colorado having one regional umbrella organization per their 14 regions and plans for SWCCOG programs to come under Region 9. Region 9 previously administered the TPR and Transit Council. She also said that Jessica has left her position and that she and Shak are covering the meetings and will work to get up to speed.

3. Next meeting date and future agenda items

The next few meetings have been scheduled and new Zoom invites will be sent out by Shak. They will continue to be hybrid meetings. Future agenda items brought up include and update on Commercial Driver's License activities and moving forward with the one stop, one click system. Laura was curious if it could be aligned with other efforts and understands she is getting back engaged and might be off track.

IV. Reports

Durango Senior Center – Vicki says they have a second bus drive and already know they need to replace some van and are looking at 2024 capital expenditures now.

Durango Transit – Matt reported that they do have some driver openings and they have been busy with the free fare August. It has been very successful. They are looking to add some of the routes they lost in 2018 as well as new fleet vehicles that got behind due to Covid. There was a lot of discussion of the delays to get chasses nationwide which had put everyone behind. Durango Transit is offering incentives to get drivers like \$350 for part-time drivers that do 10 shifts.

Roadrunner Transit – Jay discussed the Centura grant of \$100K that will allow them to expand service starting Sept. 1st. They said that they hope to cover Wildcat Canyon and as far out as Mayday and including Mayday and around to Durango West. They applied for County funding of \$114K. They need more vehicles now that their website is up, and they are proving transit to Arboles. Started Bustang service from Bayfield June first. There is no funding to go to NM, but they would like to include Aztec to get employees for the Tribe and maybe connect to Red Apple Transit. Jay reported that the free fare August has resulted in 40% higher ridership rates. Other discussion included:

- increasing vehicle costs and waiting for parts.
- There was discussion about the COTrams website and how nonuser friendly it is.
- Mentioned some transit service gaps includinCR314/318
- Communications in buses are critical and they are putting a repeater on top of Smelter. Mentioned that the Bustang radios are more reliable than cell phones.
- Looking to get some demand response software next year.

Silverton – Lucy introduced herself and interest in getting any kind of transit to Silverton. She was also interested in getting CDOT data on traffic counts. Christina mentioned that Kerri Metzler in San Juna offers gas vouchers and that their office will fund a stipend for drivers in the region. Matt mentioned that Purgatory is looking at a FT transit route that might benefit Silverton.

Area Agency on Aging – Christina was curious about the Region 9 transition for Triple A's and Laura said there was no change. Christina said modeling after Region 10 was preferable rather than DRCOG. Her total budget is \$225K which will be hard as it is at preCOVDI levels.

Archuleta Transit -Laura reported that they got money for two electric buses. They are wanting to continue to increase service but are also struggling getting vehicles. They offer every other Thursday trips from Pagosa to Durango and would like to go weekly. They also do every other week to Arboles. They are looking to develop a park n ride at the Aspen Springs Subdivision (economically disadvantaged area that already has an informal ride share). Laura said they are working on a multimodal plan to identity all those items form reroutes to bikeshare etc.

CDOT – TJ said they are working on the applications for 5310/5311 funding and agreed with the struggles on increasing vehicle prices and the lack of availability. They are trying to make their grants to cover the increases but said to definitely take care of what you have.

Montezuma – Jennifer said that they are seeing precovid ridership numbers which is good. It is a struggle to hire people and they are looking to do a feasibility study for fixed routes. She mentioned that a staff member the group knows is a first-time grandmother.
