Jim Candelaria motioned to approve the August 2020 minutes, David Black seconded, unanimously approved.

Sarah reported that Phil mentioned that a major item was related to CDOT's funding projections, and he would like to see collections versus projections at the next meeting.

2. Transportation Commissioner Report – Sidny Zink

Sidny reported that there is an opening on the Transportation Commission.

IV. CDOT Reports

1. Fed Lands Planning Pilot Updates and Overview of Phase II - Elijah Henley

Elijah presented the results of the needs assessment and next steps on the project including identification and prioritization of specific projects. There was discussion about how to move forward with prioritization of projects. He and CDOT will work to identify a meeting time to begin this process.

2. SWTPR Regional Transportation Plan Adoption - Carrie Tremblatt

Carrie presented an overview of the public comments received on the transportation plan and stated that the State is seeking approval of the final plan from the TPR. David suggested looking into road usage fees. Matt replied that several years ago CDOT had run a pilot project to begin exploring implementation of a user-based mileage fee, the initial general perception is negative due to the tracking of movements. Sarah stated that there is a draft resolution for consideration.

Jim Candelaria motioned to approve the resolution to adopt the Southwest Regional Transportation Plan, David Black seconded, unanimously approved.

4. Regional Grant Opportunities – Matt Muraro

Matt described a number of grant opportunities. The Revitalizing Main Streets for repurposing or make improvements to streets for bike and ped, \$2 million has been allocated. The Can Do Community Challenge provides smaller grants for community-wide initiatives to promote teleworking, funds must be spent in 2020. The Safe Routes to School call is out, applications are due November 5, there are some funds available with no match for heavily impacted communities with 75% or higher free and reduced lunch rates. There is a transit call for capital projects which includes a variety of funding sources. There is a Community Change grant intended to increase physical activity. Sarah asked if Safe Routes to School is a one- or two-year call. Matt replied that it is a two-year call. Sarah asked if, since the Revitalize Main Street is awarded on a rolling basis, whether previously awarded agencies may apply a second time. Matt replied he would follow-up.

V. Other Business

1. Community Updates – Round Robin

Andrea, Town of Pagosa Springs, commended CDOT's efforts on Main Street Visioning Plan. They will be submitting a request to do a speed study for the County and Town. Sarah asked if they have hired a replacement for Debbie. TJ replied that the County has hired a replacement.

Mark reported the Town of Ignacio is working with CDOT on a signalized intersection at Goddard with construction likely in the spring. They are also working on an overlay on SH 172 including looking at sidewalks and crosswalks.

Bernadette reported that the Ute Mountain Ute Tribe is working with the SWCCOG on a broadband initiative, the Tribe also plans to seek a secondary grant for fiber to the home, as connectivity has been difficult. They have hired a consultant to help with a broadband strategic plan, they may need to work with CDOT about using right of way. She added that she is currently the point person on transportation matters.

David reported that the Town of Bayfield is concluding a water line project that includes crossing under US 160. They also need to repair a culvert that failed under an irrigation ditch.

Steve reported that there was a tree removed in Dolores County which dramatically improved the line of sight, combined with mowing operations this has decreased deer collisions.

Sidny reported that she attended a meeting of the Efficiency and Accountability Committee, the discussion included closing out projects sooner since remaining funds can be used on subsequent projects if closed out sooner. The auditors had also mentioned closing projects sooner. She described the impact on fees for enterprise funds if Proposition 117 passes.

Sarah reported that the City of Durango hired a new city manager. They also hired multimodal administrator. The Needham Connect project is nearly complete and ahead of schedule. The College and 8th Street project was scheduled for construction next year, but will be delayed due to a planned project by a utility company.

Patrick asked if there is an update on the CDOT 5310 grant. TJ reported that funding decisions have been made and announcements should be made soon.

Jim Candelaria motioned to adjourn, Steve Garchar seconded, unanimously approved.
